Called to order by Bobby Flores at 3:05 pm

Opened in Prayer by Jimmy Sanders

Bobby discussed rules of the meeting included cell phones, smoking, decorum, meeting etiquette, etc.

Update on Dan Renner: Recovering well from heart incident and surgery, should be home Sunday

Bobby discussed the past 2010-2011 elections. There were no accepted nominations for the open positions of SCAA President and NFAA Director.

Jimmy Sanders made motion that we hold off on the elections until a later date. This will give the SCAA a chance to redo nominations after this meeting. Motion is seconded by Lefty Bottone.
1 Vote Yea (Swamp Fox). Motion Defeated

David Drew make a motion that the board confirm the unopposed elections of the SCAA President and NFAA Director. Motion is seconded by Lefty Bottone. Motioned passed unanimously.

Bobby has talked to Chris Norris regarding the vacant Vice President position and Chris is willing and able to fulfill this obligation— Al Brandon motions that the board elect Chris to fulfill the unexpired SCAA VP term. Motion is seconded by Russell Cooper. Motioned passed unanimously. Afterwards, Chris took some time to introduce himself.

Treasurer's report given by Jerry Williams. (attached) Noted that the 2010 awards and the late 2009 awards have not been paid for and will be reflected by the next financial report. Jerry apologized for

letting the SCAA down after his accident. Lefty Bottone makes a motion to accept the treasurer's report. Motion is seconded by David Harrison. Motion passes unanimously.

Members expressed the importance of positive communication.

Spring minutes were reviewed

Motion to suspend the reading of the spring meeting minutes is made by Jimmy Sanders and seconded by Anthony Jackson. Motion passed unanimously.

Jimmy Sanders made a comment regarding the Spring meeting and its purpose. Jimmy stated that the initial purpose was to get together in the interim and that no votes would be taken. Perry commented on that he thought the intent was not to make immediate changes and only change rules effective next year.

OLD BUSINESS

SCAA CLASS NUMBERING SYSTEM

Perry brought up numbering system for existing classes. Bobby passed out chart similar to the NC chart with slight modifications. After some discussion, Perry motioned to table numbering system. He will send club reps a numbering system to try in the upcoming year. Motion is seconded by Jimmy Sanders. Motioned passed unanimously.

NFAA NEWS

Dale – NFAA taking bids for SE sectional shoots. As long as shoots all over the section, we do not feel comfortable with hosting a shot with the limited attendance. No further discussion on speed limit. Went over NFAA shoot schedule (see shoot schedule below). NFAA went to a two year schedule. National Classic and 3d not yet scheduled. Sectional Hosts and dates not set.

POSSIBLE NEW CLUB

Introduced Michael McKnight with a possible new SCAA Club. Michael has all of the old Cedar Creek Targets. Property is very close to Rock's Pond, near Monk's Corner.

NEW BUSINESS

New VP, Chris Norris passed out handout (see attached) with recommendations regarding a upper/lower 3D championship. After discussion on matters such as award distribution, registration timing, etc. , motion to adopt this program was made by Chris Norris and seconded by Jimmy Sanders. Same members raised motion to suspend vote. Motioned passed unanimously. Voting to be made by delegate email after final version in delivered to them.

Laura Chumley talked about our need to market in sporting goods stores. Many people do not know we exist and do not know that so many 3D opportunities exist.

Bobby talked about the shooter totals for state 3D championship and the numbers that qualified for the state 3D championship.

Jimmy Sanders brought up the 300 fps speed limit. Technology has improved so much that the 280 is becoming obsolete. After much discussion about target life and running off shooters, Jimmy Sanders made a motion to move to 300 fps starting January 1. Seconded by Anthony Jackson. SF and Wateree Voted yes. Remaining clubs voted No. Motion fails.

Jimmy Sanders makes a motion that the SCAA start scoring 14s in the state shoots and as a choice for the club. 2nd by Lefty. 1 Nea (Saluda River)

Bobby talked about the misconception about the SCAA not listening to its members. The SCAA has made numerous accommodations based on member input regarding distances, adding and modifying classes, creating the SCAA circuit, capping shoot fees, and archery promotions. Encouraged the SCAA members to watch out for those that say incorrect things and to correct them when they come across misinformation.

Anthony Jackson thanked the SCAA for their support of their NASP program.

Sandune will have a traditional only shoot here in two weeks. They wanted to know if any other clubs wanted to have a traditional only shoots.

SCAA RULE BOOK REVIEW

Bobby presented a draft of SCAA rule book. Club delegates were instructed to proof read the rules and get suggestions to Bobby by September 18th.
