SCAA Officer Duties

The Board of Directors is the governing body that oversees the SCAA. This group is comprised by those in these positions: President, Vice-President, Secretary/Treasurer, NFAA Representative, Editor ("The Quiver") and one representative from each of the SCAA Archery Clubs. This Board of Directors shall have power to act (vote) on all business matters relating to the SCAA as empowered by the SCAA Constitution and the By-laws.

The following is a short list of duties for the executive positions open for nominations. For more details view the SCAA Constitution and By-laws that can be found on the forms page of the website.

Vice-President (tournament director)

- To serve as presiding officer at all SCAA State Tournaments. If unable to attend, it will be his/her responsibility to furnish a qualified presiding officer.
- To serve as public relations officer for SCAA.
- To develop a positive program for the formation and development of new clubs and to assist present membership clubs of SCAA.
- To assist and advise the President.
- To perform any other duties required by his office.

Secretary/Treasurer

- To record and maintain a permanent file of the minutes of all meetings of the SCAA and of the Board of Directors.
- To serve notice through the publication "Quiver" or by letter of all meetings of the SCAA and of the SCAA Board of Directors meeting.
- To receive all money due the SCAA and to deposit it in the name of SCAA.
- To keep accurate accounts and records of all receipts and disbursements of SCAA.
- To perform all other duties incident to the office.

Editor of "The Quiver" (public relations/advertising)

(these duties can be made current as they were written in 2001)

- To publish "The Quiver" as directed by the policy of the Board of Directors.
- To maintain information files for future referrals of publication data. To request from each club, in advance of publication of "Quiver", information from and about club members, activities and visitors. Also check and publish pertinent information from other publications that is determined to be of interest to SCAA members.
- To work closely and assist the Vice-President with SCAA public relations.
- To be responsible for ad sales and solicitation of "The Quiver" as directed by the editorial policy of the Board of Directors.

SCAA Hall of Fame
